Consumer Disclosure

1 Telehealth Certificate Series Introduction course will be automatically granted to each active APTA member who refers an individual who converts to/joins as an PT or PTA member (Prize Value: \$83.00). Limit one per APTA member.

1 APTA Telehealth Series (the six mandatory courses to complete the certificate) will be awarded each month in May, June, July, August, September, October, November, December 2021, and in January 2021, from a pool of all referring members from each month identified above (Prize Value: \$499.00).

You may enter only once, under either method (A) or method (B) below. You may not enter under both methods.

(A) Recruit an APTA Member

Recruit 1 new or rejoining APTA member and be identified by that new or rejoining member as the recruiting member and you will be automatically entered into the monthly drawing. Only one Entry Form per envelope. You may send only one envelope per Drawing Date. Incorrect, illegible, and incomplete entries are void. Once submitted, Entry Forms become the exclusive property of APTA and will not be returned.

4. Winner Selection: Selection of winners will be made by random selection from among the entries. The winners will be notified by telephone or email or both within five (5) business days after the corresponding random drawing. Two attempts will be made to contact each potential winner within a tenday (10) day period.
