	Improve access to care through reduced wait times and better patient-to-provider ratios using PT-PTA collaboration.
APTA will reduce costs to physical therapy practices to support the sustainability of the profession.	Achieve direct access for Medicare patients by eliminating the plan of care certification requirement by 2030.
	Advance at least five federal policies to ease administrative burdens and expand practice freedoms for physical therapists serving Medicare beneficiaries.
	Improve access to care and lower costs by enacting 50 state-based policies to reduce administrative burden, in collaboration with state chapters, by 2030.

APTA will empower PT-first care models to expand members' scope of practice, increase patient access, and demonstrate the value of PTs as first-line providers.	<ul> <li>Obtain expanded authorities, such as diagnostic testing, lab ordering, and limited prescription privileges, in 15 states, enabling members to deliver more comprehensive care and improve patient outcomes.</li> <li>Launch a national advocacy and public awareness campaign reaching over 1 million consumers, raising recognition of PTs' roles in health care and driving more patients to seek PT-first care.</li> <li>Position PTs and PTAs as integral members of interprofessional care teams by implementing at least three PT-first models that expand access and demonstrate the value of physical therapy.</li> </ul>
APTA will advance technology-enabled physical therapist services, equipping members with digital tools and skills that improve efficiency, outcomes, and patient engagement.	<ul> <li>Position APTA as the profession's trusted source for guidance on responsible AI use by publishing standards that support high-quality care, improve clinical efficiency, and enhance value for patients.</li> <li>Increase digital competencies in the profession by doubling the number of individuals completing APTA certifications in digital health.</li> <li>Equip members with tools to support better patient outcomes by doubling the number of users of the in the APTA Digital Health Formulary by 2030.</li> </ul>

Together, APTA's community represents the depth and diversity of the physical therapy profession. Each partner organization contributes unique expertise, insights, and reach that helps APTA in:


**Identifying payment challenges and opportunities** at the local and specialty levels, informing state-based advocacy strategies, and amplifying our collective voice.
