We can make progress in these areas which threaten our profession by empowering each and every member to see themselves as leaders.

The APTA's Board of Directors has the responsibility to ensure success in our mission by shepherding the association's resources and focusing on the needs of members and potential members in an effort to help them find their unique and purposeful role in "Building a community that advances the profession of physical



therapy to improve the health of society". The APTA's House of Delegates has an equally important responsibly to fix its sights on the horizon of our future and seek ways to move the profession towards our vision through high level and innovative policy that sets our direction. With the foresight of our Board and the leadership of our House, we have the potential to ensure an organization where everyone finds a place to belong, develop, and contribute.
