

**OFFICIAL RULES – 2020 CSM
DELTA TICKETS GIVE AWAY DRAWING**

The American Physical Therapy Association (“APTA”) is a § 501(c)(6) not-for-profit organization, located at 1111 N. Fairfax Street, Alexandria, VA 22314. In connection with the 2020 Combined Sections Meeting (“CSM” or “Meeting”) to be held in Denver, Colorado, the APTA will be holding a drawing (“Drawing”) to award certain prizes pursuant to these Official Rules.

NO FEE OR PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Prizes and Value: The four prizes are as follows:

1 of 4 certificates for roundtrip flights on Delta Air Lines and/or its participating partners, each of which will entitle the winner to a roundtrip Main Cabin ticket within the continental United States and Canada (does not include Alaska & Hawaii).

The certificate must be redeemed and the ticket issued by March 14, 2020.

The certificate may not be transferred to any other person for cash or any other consideration. Delta Air Lines imposes conditions on the use of the certificates. In the Appendix are Delta’s Redemption Notes and Terms and Conditions, both of which are subject to change by Delta.

Only one prize per person/household. Cash equivalent for prizes not available. Delta Air Lines is a registered service mark of Delta Air Lines, Inc.

2. Odds: The odds of winning will be determined by the total number of eligible entries.

3. Void Where Prohibited by Law: This contest is void in any state where prohibited or otherwise restricted by law.

4. Drawing Date: The APTA will determine the winners on or before December 1, 2019.

5. Entries: You must be 21 years of age or older and a legal resident of the United States to enter. By participating, you accept these Official Rules and agree that the decisions of the APTA interpreting and applying these Official Rules shall be final and binding in all respects.

You may enter only once, under either method (A) or method (B) below. You may not enter under both methods. Entering under method (A) will not increase your chances of winning.

(A) CSM Registration

Navigate to the CSM 2020 Rates & Registration page on the APTA's website, at [APTA.org/CSM/Registration](https://www.apta.org/CSM/Registration) and register for the conference.

All individuals who register for CSM before 11:59 p.m., Eastern Time, on Wednesday, November 13, 2019, will be automatically entered in the Drawing. Such individuals may not enter by submitting a mail entry as described in method (B) below.

(B) Mail Entry

You do not need to register for the conference to enter. Any individual wishing to participate in the Drawing may submit an Entry Form by mail. Each submitted Entry Form must be a three inch by five inch piece of paper that contains your name, complete email address, complete postal address, telephone number, and the words "APTA CSM 2020 Delta Tickets Give Away". Only one Entry Form per envelope. You may send only one envelope. Incorrect, illegible, and incomplete entries are void. Once submitted, Entry Forms become the exclusive property of APTA and will not be returned.

All individuals who submit an Entry Form by mail in an envelope postmarked on or before Wednesday, November 13, 2019, will be entered in the Drawing.

6. Winner Selection: Selection of winners will be made by random selection from among the entries. The winners will be notified by telephone and/or email and given the opportunity to accept the prize.

7. Winner: The winners shall be the persons named on the first entries selected that contain all the information required. To receive a prize a person must disclose to the APTA any information (e.g., social security number) the disclosure of which may be required by applicable tax or other law. Individuals who fail to respond by telephone and/or email within 72 hours of the initial notification will be disqualified, and their prize will be awarded to another entrant. In order to redeem the certificate a winner must follow the procedures set

forth by Delta Air Lines in its Redemption Notes and Terms and Conditions set forth in the Appendix, both of which are subject to change by Delta.

Additional Terms: By entering the Drawing, each participant agrees to release, discharge, and hold harmless the APTA, its affiliates, subsidiaries, officers, directors, employees, and agents from any and all damages, costs, expenses, and other liabilities, including damages for personal injury or damage to property, whether the damages are direct or indirect, and regardless of whether the claim is based on contract, tort, or any other legal theory, which may be due to or arise out of participation in or operation of the Drawing or any portion thereof or the acceptance, use/misuse, or possession of the prize.

By entering, each participant further agrees that no warranty, representation, or guarantee, express or implied, in fact or law, has been made with respect to the prize. Entries that are lost, late, misdirected, incorrect, garbled, or incompletely received, for any reason, including by reason of hardware, software, browser, or network failure, malfunction, congestion, or incompatibility at servers or elsewhere, will not be eligible. TERMS AND CONDITIONS

Reservations/Ticketing:

Reservations must be made and tickets issued prior to departure. Tickets must be issued within 24 hours of making reservations. Reservations made on delta.com must be ticketed at time of reservation. The number of seats available for this offer is limited.

1. Certificate Validity:

Certificate must be redeemed and ticket issued by the date stated above. Extensions will not be granted under any circumstances.

2. Booking Class:

Refer to the Certificate Summary above. If this certificate is valid for travel in Delta Comfort+? both W and L class must be available to confirm a Delta Comfort+? seat.

3. Fare Basis Code:

*GRATIS (*Insert applicable booking class. Ex: YGRATIS).

4. Minimum Stay:

None.

5. Maximum Stay:

Travel must be completed within 331 days of the booking date.

6. Blackout dates:

None

7. Itinerary:

Stopovers, open segments and wait listing are not permitted, in addition if this certificate is valid for roundtrip travel, circle and double open-jaw trips are not permitted. For certificates that are valid for roundtrip travel, single legal open-jaw itineraries are permitted.

8. Carrier Combinations:

The use multiple marketing carriers is not allowed, all ticketing must be complete using a single marketing carrier from origin to destination.

9. Stopovers:

Stopovers of more than 4 hours for domestic travel or 24 hours for transoceanic travel are not permitted.

10. Routing:

Travel on DL is valid via DL published routings on DL published fares for the permitted area of travel for this certificate. If this certificate is valid for international travel, non-DL operated flights, if permitted, are only valid for Transatlantic travel between the US (including Puerto Rico)/Canada/Mexico and Europe/Middle East/Africa. Schedules are not guaranteed and are subject to change without notice. Involuntary denied boarding compensation, if applicable, will not be paid.

11. Transferability:

The certificate is transferable only if it is not associated with an individual's name. Exception: If the certificate is issued in an individual's name, the certificate may be used by a different person as long as the original recipient is traveling with that person in the same reservation. Certificates may not be transferred for cash or any other consideration. Purchased and/or auctioned certificates are subject to confiscation and travel will not be permitted.

12. Taxes/Fees:

Additional taxes/fees/surcharges/inspection and security fees may apply. PFCs do not apply. Any tax liability or other government imposed fees are the responsibility of the user.

13. Changes/Refunds:

Once ticketed, tickets are nonrefundable after **risk free** cancel expires. Changes are permitted for a fee, the **fee** is based upon the ticketed origin and destination, provided the new itinerary meets all provisions of the program.

14. Baggage Fees:

Standard **baggage fees** apply and are the responsibility of the passenger.

15. Upgrades:

Not permitted.

16. Combinability:

This certificate may not be combined with any other discount, promotional fare also known as a web fare, infant fare, child fare, senior fare, e-cert, coupon, certificate, ticket designator, reference code, upgrades, promotions or group fares. This certificate only permits travel on a single marketing carrier in each direction, use of multiple marketing carriers in the same direction of travel is not permitted.

17. Certificate offer:

Limit of one ticket per certificate. Certificate has zero cash value, will be deemed fully used upon surrender and will not be honored retroactively or in connection with the exchange of any wholly or partially unused ticket. Certificate will not be replaced and cannot be

requested. The use of the certificate offer embodied herein by anyone other than Delta in any advertisement for any purpose, or the purchase or other acquisition of certificates by persons or entities in the travel service business is strictly prohibited and will render the certificate VOID.

18. SkyMiles:

SkyMiles mileage credit will NOT be awarded for travel with this certificate.

19. Certificate Expiration:

Certificate expiration is as of midnight Eastern Standard Time on the date note above. Travel must be ticketed prior to the certificate expiration date.
